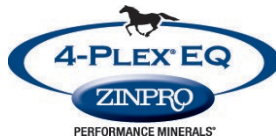

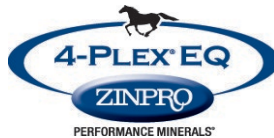

Feed Agland Stampede Senior 14% Complete Pellet at the rate of 1 1/2 to 2 pounds per 100 pounds body weight daily according to level of activity. If hay is fed, reduce the amount of Agland Stampede Senior 14% Complete Pellet by 1 pound for every 2 pounds of hay consumed. Water may be added to feed to form a slurry for feeding to horses that are prone to choke or have poor teeth. Use a scale or weight tape to determine weight of horse. To attempt to achieve body weight gains of 0.5 to 1.0 lbs per day, feed an additional 3 to 4 lbs of Agland Stampede Senior 14% Complete Pellet daily. Provide fresh clean water at all times. DO NOT FEED TO SHEEP DUE TO HIGH LEVELS OF SUPPLEMENTAL COPPER.

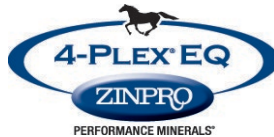

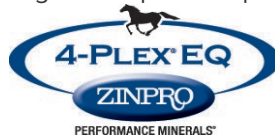

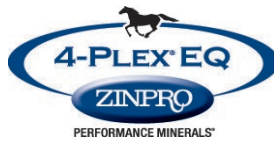
